



Bid Processing Fee/cost of RFP document(Non-Refundable) is mandatory to be paid through online mode i.e. Internet payment gateway(Credit/Debit card),Net Banking,NEFT/RTGS.Scanned copy of the receipt must be submitted along with Bid through e- procurement portal [www.eproc2.bihar.gov.in](http://www.eproc2.bihar.gov.in) on or before date and time specified in NIT.
