#### **5. Earnest Money :-**

6. In Payment mode of Earnest Money Deposit Online/Offline (Only Bank Guarantee) instrument will be valid as EMD (As per dep. Lt No-5651(E) Dt 19.08.2020) BG of Nationalized/ scheduled bank shall be submitted. EMD is duly endorsed/ pledged to the Senior Project Engineer, Works Division, Muzaffarpur, Bihar Rajya Pul Nirman Nigam Limited. /Dy. Chief Engineer, Work Circle-1, Bihar Rajya Pul Nirman Nigam Limited. Patna, 7, Sardar Patel Marg, Patna. The BG shall be issued on/ after the start date of uploading the bid document by the employer and refer/ up to the stipulated last date of uploading the bid by the bidder, shall as applicable. It should be valid for not less than 180 days.

7. The successful Bidder at the end of the Bidding process may be awarded a contract by BRPNN Ltd. to implement the project on EPC Mode,. The Contractor (successful bidder) shall be responsible for the Design, Engineering, Procurement, Contraction and Maintenance of the project in terms of the agreement to be signed between the contractor and Senior Project Engineer, Works Division, Muzaffarpur, Bihar Rajya Pul Nirman Nigam Limited.
